

Safeguarding Committee summary of safeguarding General Assembly Deliverances, 2000–2018

Introduction and purpose

The following tables list Safeguarding Committee General Assembly deliverances since 2000 by:

(1) Safeguarding subject and in

(2) Chronological order

These deliverances set standards for best practice in safeguarding – what safeguarding should look like in practice, its structures, policies and procedures. They also identify *instructions* and recommendations for Presbytery and Kirk Session to implement. The goal is to 'ensure a safe Church for all.'

The information can be used as a checklist, and plan for action, by Safeguarding Coordinators, Kirk Sessions, Session and Presbytery Clerks, Presbytery Safeguarding Contacts and Safeguarding Trainers. The collated deliverances will assist implementation of best practice and save Church members having to plough-through volumes of the Blue Book to find instructions about particular safeguarding subjects. References to Kirk Sessions are highlighted in bold.
