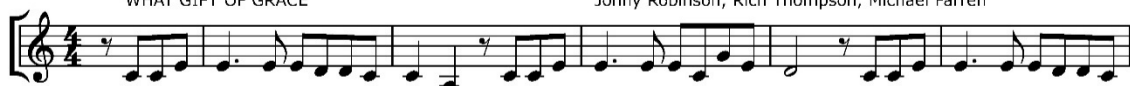

Proposed Deliverance

The General Assembly:

1. Receive the Supplementary Joint Report.
2. Instruct the Assembly Trustees and The Church of Scotland Trust to lease the Scots Hotel to the preferred operator, or to another hotel operator which meets the selection criteria set out in the Joint Report, for a maximum period of 24 years and 11 months and on the commercial terms set out below and to be further agreed by the Assembly Trustees and the Church of Scotland Trust in line with professional advice received by them in the UK and in Israel.

Note: the intention is to withdraw section 2 of the proposed deliverance of the Joint Report and instead move section 2 of the proposed deliverance of this Supplementary Joint Report.

Executive Summary

The Assembly Trustees and Church of Scotland Trust commend the continued hard work and faithfulness of the hotel staff and directors throughout the recent difficult and uncertain geo-political circumstances, acknowledge the uncertainty resulting from the exploration of a lease of the hotel and its continued operation, and record gratitude for their sustained efforts and commitment.

The preferred operator identified by the Assembly Trustees and the Church of Scotland Trust is an established hotel company operating in numerous locations in Israel and internationally and which is part of a larger established group.

The preferred operator has a:

- very good reputation and operates under sound and efficient business practices.
- management team who are highly experienced in the hospitality sector and effective in their respective roles.
- current portfolio of hotels which are maintained to a high standard and offer excellent facilities and guest service.
- strong market reach throughout Israel and internationally.
- growing customer base supported by an expanding loyalty programme which drives high occupancy rates and hotel guest expenditure.
- capacity and commitment to refurbish and operate the Scots Hotel to a high standard and in keeping with the Christian ethos and heritage of the Church's ownership.

A review by PwC of the financial due diligence of the parent group provided confidence in its ability to meet the required payments of annual rent and the commitments to the initial refurbishment and then the ongoing maintenance of standards within the Scots Hotel, even in times of challenging local conditions.

INTRODUCTION

The negotiations with the preferred operator are commercially sensitive and accordingly not all of the details can be made public nor can the identity of the preferred operator be disclosed at this stage. It is anticipated that the identity of the preferred operator will be disclosed at the General Assembly. As much information as possible is summarised below while observing commercial confidentiality.

1.1 In recent weeks the Working Group established by the Assembly Trustees have engaged regularly with the preferred operator to negotiate in detail the terms of the proposed lease.

1.2 Subject to the agreement of the General Assembly to lease the hotel to the preferred operator, the agreed terms of the lease will commit the preferred operator to continue to operate the Scots Hotel in accordance with the current Christian ethos, maintain the heritage of the hotel, provide employment opportunities for staff and support small suppliers. A substantial, index-linked annual rent will be paid to St Andrews Galilee Ltd. After payment of estimated local operational costs and taxation the rent payable, will realise predictable, long term cash flows for the Church with a reduction in fluctuations caused by local conditions. St Andrews Galilee Ltd will be sustainable and the Church's available unrestricted funds will be increased, thereby providing funding for growth and mission.

1.3 Below is further information on the major benefits that this lease will deliver to the Church of Scotland, the key aspects of the proposed lease, and the latest financial position of the hotel.

2. BENEFITS OF THE LEASE TO THE CHURCH OF SCOTLAND

2.1 The proposed lease offers the following benefits to the Church:

- Christian land and Christian presence – the lease enables the Church to retain ownership of the land and buildings. This coupled with the retention of the hotel's name and branding, recognition of ownership and the ongoing operation of the visitor centre will continue to demonstrate the Church's ongoing commitment to the land and support for local Christians and Ecumenical partners.
- Christian Ethos – The commitment of the preferred operator to operate the hotel consistently with the Christian ethos policy will maintain the hotel as a place in which all are welcome regardless of

faith, nationality or background and operated in a manner consistent with fostering mutual understanding. Staff of diverse faiths, backgrounds and ethnicities will not face discrimination on grounds of religion, race, ethnicity, nationality, gender or disability and will enjoy fair wages, working conditions and training opportunities in line with hospitality industry best practice and in compliance with Israeli employment law.

- The funds available from rent received after deduction of operational costs and taxes will provide a reliable and substantial cash flow each year, conservatively estimated over the period of the lease to be an amount in excess of £22m. This will enable the Church to:
 - Develop and support mission in Israel and Palestine.
 - Support the growth of the Church and its mission in Scotland and elsewhere.
 - Fund the necessary repair and ongoing maintenance (e.g. roofs, electrical systems, drainage etc.) of the hotel buildings and infrastructure, maintaining and enhancing the condition and value of this important heritage asset.
 - Receive repayment of the loan made to St Andrew's Galilee Ltd.
- The preferred operator will pay for the much-needed immediate refurbishment of the hotel, including upgrading operating equipment, furniture, fitments and décor in public areas and guest bedrooms and bathrooms - costs which neither the hotel nor the Church can fund currently.
- The preferred operator will be responsible for the ongoing costs of maintaining guest facilities and services to the current standard or higher.
- Transfer of financial risk from the Church to the preferred operator namely:
 - The reduction in income and profitability in periods of poor trading will fall to the preferred operator and no longer result in losses to be met by the Church.
 - During times when the hotel is closed and with no income, costs of essential staffing and standing charges must continue to be met. Currently, these are calculated to be over £100k per month. Responsibility for such costs will, in future, be met by the preferred operator.

- Most of the current staff will be offered employment by the new operator. If the hotel was forced to close or be sold all staff employment would be immediately at risk and the Church could not commit to ongoing employment of current staff.
- Agreement of the proposed lease reduces the risk of insolvency for St Andrew's Galilee Ltd.
- The lease will bring an immediate income stream through rent payments to St Andrews Galilee Ltd. This will enable payment of operational costs of St Andrew's Galilee Ltd, will fund the necessary repairs to the hotel and, over time, will facilitate the repayment of the loan to the Church of Scotland Trust.

3. KEY ELEMENTS OF THE LEASE

3.1 Whilst the full details cannot be disclosed the key elements of the proposal are:

- The lease will be for 24 years and 11 months maximum, with 2 break points.
- The preferred operator will adopt the Christian Ethos policy defined by the Assembly Trustees. It includes adherence to non-discrimination practices and laws, providing employment of staff and hospitality to guests of differing faiths, ethnicities, backgrounds, gender and disabilities, treating all with respect, dignity and mutual understanding, marking major Christian festivals, in particular Christmas and Easter, and working in cooperation with our Mission Partners.
- In keeping with the Christian Heritage, the name and brand of the hotel will be retained, it will remain non-kosher, the Visitor Centre and displays will be retained with access provided to Christian pilgrims and other groups.
- Staff of the hotel will be employed on the same or similar terms and conditions of employment as at present. All staff employed by St Andrew's Galilee Ltd will be subject to redundancy procedures and will be entitled to full severance pay from St Andrew's Galilee Ltd.
- Purchasing from local, small suppliers with whom the hotel has established supply relationships will continue wherever commercially reasonable.
- The value of the rent is substantial, in line with sector standards for a hotel of this size and quality. Our professional advisors have

confirmed that this offers a very fair return to the Church. The rent will increase each year in line with Israeli CPI, thereby maintaining the real terms value of the rent. In addition, there will be a further uplift at an agreed point.

- The preferred operator will invest over years 1 to 3 of the lease term in the refurbishment of the hotel a substantial sum considerably in excess of that identified by the directors as necessary.
- Thereafter a minimum percentage of the gross revenue (in line with industry standards for this standard of hotel) will be allocated annually by the preferred operator to the ongoing maintenance of furniture, fitments and equipment within the hotel to the preferred operator's standard.
- The following activities are explicitly prohibited:
 - No gambling activities will be carried out from the hotel nor will the operation of a casino or nightclub be permitted from within the hotel premises.
 - No promotion of political or sectarian positions will be permitted by the hotel.
- Appropriate bank guarantees will be in place in respect of rental payments.
- Mechanisms will be available to enable the Church to exit the lease if there is a major and unresolved breach of the lease conditions by the preferred operator including a failure to cure breaches of the Christian ethos policy.
- The directors of St Andrews Galilee Ltd will engage positively with the preferred operator building a relationship that will enable prompt resolution of any issues which might arise during the term of the lease.

4. FINANCIAL PERFORMANCE OF THE HOTEL

4.1 In addition to the key financial results of the hotel set out in the Executive Summary of the Joint Report the following should be noted:

- Cash provided since December 2025 to the hotel to support ongoing operations was £0.34m. Some of this may be repaid by the Israeli Government when war compensation is received.

- Trading conditions remain difficult due to the ongoing geo-political situation. The directors have budgeted a deficit for 2026 of £0.65m.
- The full report of the building survey commissioned by the Assembly Trustees has yet to be considered. However, the preliminary information provided by the surveyors indicates that there are several aspects of the building and infrastructure which require repair and maintenance, the costs of which would be borne by the owner, not the lease holder. St Andrews Galilee Ltd has insufficient funds available and therefore these costs will have to be funded by the Church.

5. PROPOSED STRUCTURE

5.1 After careful consideration of options and expert Israeli and UK tax advice from PwC and Azets, it is proposed that the Church of Scotland Trust will issue a new lease for the hotel to St Andrews Galilee Ltd and in turn St Andrews Galilee Ltd will lease the hotel to the preferred operator. This approach fits within the structures we have, requires no change to the purpose of the Church of Scotland Trust, maintains St Andrews Galilee Ltd and is considered to meet the necessary tax requirements in the most efficient way.

5.2 In the negotiation of the terms of the lease detailed advice and guidance has been sought from HVS and Firon Law Firm on Israeli legal requirements and hospitality industry standards and what the Church should aim to achieve for the Scots Hotel to meet its requirements. The Working Group have held regular meetings with representatives of the preferred operator. These negotiations have been challenging as each party has pressed for terms which meet their objectives. Throughout these meetings the Working Group has sought to strike an appropriate balance between maintaining the Church's Christian ethos and presence in the area and achieving a strong and reliable financial return to the Church. All discussions with the preferred operator have been conducted in good faith and it has been clear that both parties seek to establish a positive, long-lasting relationship with outcomes which are fair and to the benefit of both the hotel company and the Church of Scotland.

6. CONCLUSION

6.1 Following much careful and prayerful consideration, The

Assembly Trustees and the Church of Scotland Trust commend to General Assembly the proposed lease of the Scots Hotel to the preferred operator on the terms and conditions set out above. It enables continuity of presence in the area, and continued ownership of Christian land. It demonstrates and will enable our ongoing commitment and support to local Christians and ecumenical partners, coupled with the development of our Christian mission in Israel and Palestine. It offers staff positive future employment opportunities and provides much needed sustained income for the Church to maintain this heritage building and to support and grow the Church and its mission in Scotland and elsewhere.
