**Main Purpose of post:** To work with the Minister, as a member of the Ministry

Team, and the Kirk Session to provide the full range of Parish Ministry to the St Columba's congregation.

#### **MAIN DUTIES**

### Worship

- The leading of public worship on Sundays at St Columba's in partnership with the Minister. This will include preaching, leading prayers and celebrating the sacraments. On a minimum of twelve Sundays each year the Associate will lead worship in the absence of the Minister.
- Conduct public worship on days other than Sunday as required, including funerals of members and non-members and school assemblies.

### Youth & Education

- Take a lead role in ministry to youth by supporting existing groups e.g. crèche, Sunday School, and develop ministry to young families, older teenagers and Young Adults.
- Take a lead role in adult education by supporting existing groups e.g. Happy Hour, Women's Bible Fellowship, seasonal studies.

### **Pastoral**

- To supervise and undertake, in consultation with the Minister, Pastoral Visiting Group and elders, the routine pastoral visitation of elderly/sick/housebound.
- To undertake emergency pastoral visits as directed by the Minister.

 To undertake an agreed share of pastoral duties i.e. baptisms, weddings, funerals and related pastoral visitation and preparation.

## Chaplaincy

 Assisting in current chaplaincy to Hill House & Knightsbridge Schools (local preparatory schools).

# Responsibility/Development

- Participate in regular staff meetings with Minister and elders.
- Identify, in co-operation with the Minister and others, areas of the life and work of St Columba's for which you will take responsibility.
- Identify, in conjunction with the Minister and others, areas for development in the life of St Columba's e.g. Worship, Youth, Pastoral Care, Education.
- Carry out any other tasks as reasonably required by the Minister.
- Engage in personal and professional development as appropriate.

### **Terms and Conditions:**

- Remuneration shall be based on the Church of Scotland Stipend scale which is currently £27,585 - £33,899 per annum.
- Whilst normal hours of work will be 37.5 hours per week as agreed locally, the nature of the work calls for a degree of flexibility, thus hours of work, which are as agreed with the Parish Minister, may vary from day to day.
- Accommodation will be provided. The accommodation is a four bedroom house in South West London.
- The post is based in St Columba's, Pont Street, London.
- There are 6 weeks annual paid leave in each full holiday year which runs from 1
  January to 31 December. Entitlement is based on full months worked. There are
  also 5 statutory holidays.
- Travel expenses by public transport or by use of own car at rates as agreed by your Employer and reviewed annually. Car mileage and allowance will be paid by the Employer in the first instance and re-claimed from the congregation on a quarterly basis.

- The successful applicant will have the opportunity to join a Retirement Benefit Scheme in cooperation with a life assurance society
