### Sources of Finance for Repair and Improvement

#### Introduction

This guide is not comprehensive but should provide useful starting information. It should also be emphasised that most of the organisations mentioned will not consider assisting projects which have already got underway. There are a number of other local trusts peculiar to particular localities in Scotland. Each of the trusts has different requirements for applications to them and it is important to make EARLY CONTACT to check individual requirements. For the purposes of applications to Historic Environment Scotland and the Heritage Lottery Fund there are now two submission dates for applications, at the end of February and August in each year. Each of these organisations uses a joint application form and if a congregation is seeking to apply only for Historic Environment Scotland funds, and not Lottery funding, this should be made explicit either in a covering letter or in the form itself.

#### CHURCH OF SCOTLAND – CENTRAL FABRIC FUND

Loans and grants are available from this Fund which is operated by the Church of Scotland General Trustees for the purchase, building, repair and improvement of Churches, Halls and Manses and in certain other special cases as determined by the General Trustees. All applications must be submitted via the local Presbytery Office. ### LOCAL AUTHORITIES

Local Authorities may but do not require to contribute towards the expense incurred or to be incurred in the repair or maintenance of:

- (a) A listed building which is in their local government area; or
- (b) A building in their area which is not listed but appears to them to be of architectural or historic interest.

Further information may be obtained direct from the Chief Executive or Director of Administration of the local authority concerned.

### PRIVATE TRUSTS

### (1) Allchurches Trust Ltd

The objects of the Trust include contributing to the funds of a charitable institution but the majority of the donations are to dioceses and cathedrals of the Church of England. ### (9) Dalrymple Donaldson Fund

The income on this fund is used for the purpose of making grants for the judicious restoration and repair of buildings of historical and antiquarian interest and the Trustees have from time to time made grants to congregations where appropriate. # (13) Lloyds TSB Foundation for Scotland

The Foundation seeks to help those in need, especially the disabled and disadvantaged, in order that they can play a fuller role in society. Grants will not therefore be given for repair or maintenance work but may be given where a building is being improved so as to be of benefit to the wider community – eg by the installation of an access lift for disabled persons. ### • PRESBYTERIES IN THE CHURCH OF SCOTLAND

Some local Presbyteries hold funds from which grants can be made for fabric repair and improvement. Apply to the relevant Presbytery Clerk.

### • LANDFILL TAX CREDIT SCHEME

A portion of the Landfill Tax levied by the Government on operators of landfill sites may be used to support the maintenance, repair or restoration of a building in use for religious worship so long as the building is open to the public, non-profit making and located within

the vicinity of a landfill site. ## • LOTTERY FUNDING

### (1) Big Lottery Fund

The Fund operates a number of funding programmes including "Investing in Communities", "Awards for All", "Investing in Ideas", "Life Transactions", "Supporting 21<sup>st</sup> Century Life", "Dynamic Inclusive Communities" and "Breathing Spaces". The focus tends to be on assisting projects which will make a real difference at a local level. The provision of modern facilities may qualify. ### (2) Heritage Lottery Fund

Administered by the Trustees of the National Heritage Memorial Fund, this is one of the "good causes" funds supported from the proceeds of the National Lottery. ### HISTORIC ENVIRONMENT SCOTLAND

As with the scheme run by the Heritage Lottery Fund, grants are given for urgent repairs at listed buildings. #### • LISTED PLACES OF WORSHIP GRANT SCHEME

Strictly speaking, this is not a grant so much as a refund by the Treasury of the amount of the VAT charged on repair and maintenance work on listed places of worship.
